1. SERVICES PROVIDED

Four Paws Pet Sitting agrees to provide pet sitting services, which may include but are not limited to:

- Feeding, watering, and walking the pet(s)
- Administering medications (if needed)
- Cleaning litter boxes or cages
- Any other services agreed upon by both parties (specified if needed).

2. PET CARE INSTRUCTIONS

The Pet Owner agrees to provide Four Paws Pet Sitting with detailed instructions on the care of their pet(s), including, but not limited to:

- Diet & feeding schedule
- Emergency contact information (vet, friend, or family member)
- Any special medical or behavioral needs

- Security or access instructions for the pet's environment
 - Any other important information related to the pet(s).

3. LIABILITY WAIVER

The Pet Owner acknowledges and agrees to the following:

- **Accidents and Injuries:** Four Paws Pet Sitting will take all reasonable care in providing care to the pet(s). However, the Pet Owner understands that accidents and injuries may happen, and the Pet Sitter cannot be held liable for any damages or injuries to the pet(s) during the provision of services.
 - **Emergency Medical Treatment:** In the event of a medical emergency, the Pet Sitter will attempt to contact the Pet Owner or the emergency contact provided. If the Pet Owner cannot be reached, the Pet Sitter is authorized to seek veterinary care at the Pet Owner's expense.
 - **Pet Behavior:** The Pet Owner understands that Four Paws Pet Sitting will not be held liable for any behavioral issues that arise during the pet sitting services, including damage to property, aggressive behavior, or other unforeseen circumstances.
 - **Property Damage:** The Pet Owner agrees to hold harmless Four Paws Pet Sitting for any damage to property that may occur as a result of the pet's actions during the service period.
 - **Social Media and Website Consent:** By signing this agreement, you acknowledge and consent that during the dog sitting services, photographs or videos of your animal may be taken. These images may be shared on the sitter's social media platforms (such as Instagram, Facebook, etc.) and/or the sitter's website for promotional purposes. If you do not wish for your pet's photos to be shared, please notify the sitter in writing prior to the start of the services.

4. CANCELLATION POLICY

The Pet Owner agrees to notify Four Paws Pet Sitting at least 48 hours before the scheduled service date for cancellations. If a cancellation is made less than 48 hours in advance, the Pet Owner agrees to pay the full amount of the agreed fee.

5. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the parties. No oral statements or prior written material not specifically incorporated herein shall be of any force and effect. The Pet Owner and Four Paws Pet Sitting may amend this agreement in writing at any time by mutual consent.
